Despite procurement regulations, DCAA many times does not have access to all of the contractor's records necessary for an effective audit. DCAA has not followed up adequately on the reports it issues; and contracting officers often have not provided the feedback necessary for the agency to improve its service. The low priority given to defective pricing reviews seems inappropriate. Time constraints and an excessive work load have sometimes resulted in substandard audit work.
